- Social security; Yes. You will join Welfare Pension and Health Insurance program (If you are now under coverage of your parent's Japanese social security program, your parent's status of tax exemption for dependents will be revoked and your parent's Japanese tax premium will be increased. This is applicable only to the case where your parent joins Japanese social security program. And you will pay the premium though your salary by yourself. If your own income earned in Japan during calendar year 2019 or 2020 exceeds 1,030,000 yen per year, you need to return income tax to Japanese National Tax Agency.)
- Worker's compensation; Yes
